The meeting started with key note address by Mr Ajay Banga Chairman of ICC HQ and CEO of Master Card International, The meeting adopted previous minute of the meeting of ICC World Council No 210 and also appointed President, Vice President of ICC Court of Arbitration and also Court Members from each country where ICC Thailand nominated Ms. Noppramart Thammateeradaycho, Counsel of Tilleke & Gibbins International as its representative. The meeting also appointed Member of The ICC Executive Board.

Mr. John Denton, Secretary General of ICC HQ reported on various of ICC activities including Global vaccines Campaign Update, Regional Engagement of Agri-Food, WTO Reform, Digital Standard Initiative, SME Climate Hub and ICC SME 360X tool overview, Deployment of NC development fund, Center of Entrepreneurship, A new network of High Level SME Champion, Focus on Africa and A new look for ICC, ICC AOK Pass etc.

The meeting approved article of association of ICC Lithuania and ICC Egypt and amended constitution change of Abu Dhabi and Shanghai, And also approved new members / discontinue members of each country.

The meeting acknowledged activities reported by International Court of Arbitration, ICC World Chamber Federation and ICC Institute of World Business Law.

Connectivity and tourism recovery from COVID-19

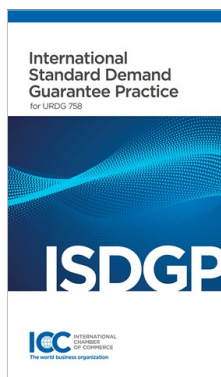
